1. WELCOME  
The Chairperson welcomed everyone present and thanked John Davies DC and Paul Roberts ADC and Minister Brenton Prigge for coming.
2. APOLOGIES FOR ABSENCE

### **EXPLORER SCOUT SECTION REPORT 2022/2023**

Summer camp for the Explorer Scout section this year was a joint adventure with the Scouts to an activity center called Blackwell Court, in Bromsgrove. While there the Explorers took part in a number of exciting activities including tree trekking, a 3G swing and laser tag in the woods. We also spent some time off the site, visiting Drayton Manor theme park, The Wave waterpark in Coventry and even going on an overnight expedition to the nearby Pikes Pool campsite. There was a definite tension in the air as teams faced off in the annual cooking contest. The ambition and quality of the meals planned, budgeted, bought and prepared by the young people was considerable . The judges had the difficult task of picking a winning team to award the trophy to and this year the winning team was headed by Annabelle.

The programme over the past year has been a combination of nights at our Shaugh Bridge campsite and the hall at Compton. This year the Explorers have had a range of activities including climbing and abseiling at the Dewerstone, a treasure hunt around the City Centre and a wide range of cooking challenges both on stoves and on the fire at the campsite. In February the explorers took on some Escape Rooms, where teams were challenged to solve a series of puzzles to open doors and get out against the clock. They also played a game of Capture the President where teams were challenged to get a picture of each other's elected "president" while moving around the local area without getting caught on camera themselves.

So far, we have awarded 76 badges this year, with almost as many again due to be awarded following after the summer activities. Notable among these is the Chief Scout's Platinum award, one of the highest awards in scouting and congratulations go to Brandon, who has received this badge in the last year.

Congratulations also go out to the 11 Explorer scouts who took part in Ten Tors this year.

We are grateful as ever to all the families and leaders who have continued to support us throughout the year.

We would also like to thank our young leaders, who give their time to help with other sections within scouting.

### **TREASURER'S REPORT 2022/23**

In the 2022-2023 financial year we saw a significant growth in expenses as activities returned to pre-pandemic levels. There was also a corresponding increase in income relating to some activities and camps plus an increase in subscription income as the number of young people increased in the group. With greater use of the campsite at Shaugh we have also spent almost £2,400 on the hut at the camp site, some of which was funded by a Tesco grant. The grant from Plymouth Rotary, received for helping them with their Christmas collection, has also helped to subsidise activities.

We received £1,778 from the government via the Gift Aid programme. This treats the subs that you pay as donations and the government add an extra 25% on top of that. If you are a UK tax payer, please click the Gift Aid box in OSM.

We spent 56% more on badges than in the previous year which is a testament to the great work of the leaders in all sections. They are providing a wide range of activities and our young people are learning a lot.

In the current year there is a significant increase in the amount of subscriptions that we need to pay onto the higher levels of the scouting organisation. We have chosen to keep our subscription fee the same but we will need to monitor this carefully.

Overall for the year, we spent £1,840 more than we received in income. We have sufficient reserves to absorb this. There was a surplus of £3,400 last year because we hadn't yet spent the money on the planned repairs. If we take into account that we spent £2,400 on one-off repairs to the campsite hut then we can see that ongoing income and expenses are quite well matched.

We have £10,643 in our reserves which are adequate to meet our commitments.

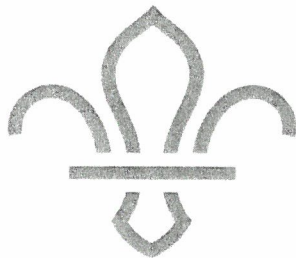

### Governance

The Group's governing documents are those of the The Scout Association. They consist of a Royal Charter, which in turn gives authority to the Bye Laws of the Association and The Policy, Organisation and Rules of The Scout Association.

The Group is managed by the Group Executive Committee, the members of which are the 'Charity Trustees' of the Scout Group which is an educational charity. As charity trustees they are responsible for complying with legislation applicable to charities. This includes the registration, keeping proper accounts and making returns to the Charity Commission as appropriate.

This Group Executive Committee, comprising the leaders of each section, office holders elected at the AGM and other volunteers to balance with the leaders, exists to support the Group Scout Leader in meeting the responsibilities of the appointments and is responsible for:

The maintenance of Group property;

The raising of funds and the administration of Group finance;

The insurance of persons, property and equipment;

Group public occasions;

Assisting in the recruitment of leaders and other adult support;

Appointing any sub committees that may be required;

Appointing Group Administrators and Advisors other than those who are elected.

### Public benefit

The Group meets the Charity Commission's public benefit criteria under both the advancement of education and the advancement of citizenship or community development headings.

### Aim

The Aim of The Scout Association is to promote the development of young people in achieving their full physical, intellectual, social and spiritual potentials, as individuals, as responsible citizens and as members of their local national and international communities. The method of achieving the Aim of the Association is by providing an enjoyable and attractive scheme of progressive training, based on the Scout Promise and Law and guided by adult leadership.

### Reserves policy

The Group's policy on reserves is to hold sufficient resources to continue the charitable activities of the group should income and fundraising activities fall short.

The Group does not hold any insurance policies but maintains an unrestricted insurance fund to pay for any insurance needs.

### Financial review

The Group had a deficit of £1,839.65 (2022: surplus £3,406.91).

This increased reserves to £10,642.90 (2022: £12,482.55) which are considered prudent and sufficient to meet future activities.

#### 1 Accounting policies

Membership subscriptions are recognised on a cash received basis.  
Subscriptions are collected from parents and guardians and shared between sections and the group.  
Sections use subs for their activities and the group for group costs.  
The group pays subs per child to the Scout District.  
Fees for activities represent money collected by sections for camps and other activities.  
Assets are written off in the year of purchase.

#### 2 Grants and donations

£488.22 was received as a grant during the Covid pandemic and was used for rent. £1,000 was received from the Ballard Trust. £400 was received from Plymouth Rotary. £200 was received through one-off donations. £55.95 was received from Amazon because of purchases made by parents and friends.

#### 3 Donations

Money raised on behalf of the Children's Society was £253 (2022: £53).

#### 4 Prepayments

Prepayments represent amounts paid in advance for activities, such as deposits for camps, photocopying and amount held on gift cards.

#### 5 Deferred income

Deferred income relates to money collected by sections for future activities.  
This will be recognised as income when the activity occurs and matched against the future expense.

#### 6 Related party transactions

Trustees are recompensed for expenses incurred on behalf of the group.  
Scout leaders may receive training, qualifications and membership fees paid by the group.

#### 7 Payables

Payables relate to expenses owed to the section leaders and not paid before the end of the year plus subs collected by the group and owed to sections.

## Independent examiner's report to the trustees of 27<sup>th</sup> Plymouth Scout Group

I report to the trustees on my examination of the accounts of the 27<sup>th</sup> Plymouth Scout Group for the year ended 31 March 2023.

### Responsibilities and basis of report

As the charity trustees of the 27<sup>th</sup> Plymouth Scout Group you are responsible for the preparation of the accounts in accordance with the requirements of the Charities Act 2011 ('the Act').

I report in respect of my examination of the 27<sup>th</sup> Plymouth Scout Group accounts carried out under section 145 of the 2011 Act and in carrying out my examination I have followed all the applicable Directions given by the Charity Commission under section 145(5)(b) of the Act.

### Independent examiner's statement

I have completed my examination. I confirm that no material matters have come to my attention in connection with the examination giving me cause to believe that in any material respect:

1. accounting records were not kept in respect of the 27<sup>th</sup> Plymouth Scout Group as required by section 130 of the Act; or
2. the accounts do not accord with those records; or
